BLAZER SKI CLUB ACKNOWLEDGMENT AND RELEASE

IMPORTANT: THIS AGREEMENT MUST BE CAREFULLY READ AND SIGNED BEFORE ACTIVITIES WITH THE BLAZER SKI CLUB MAY BE UNDERTAKEN.

BY THIS AGREEMENT, YOU ARE ACKNOWLEDGING THE LAW AND GIVING A RELEASE FROM LIABILITY, INCLUDING FROM NEGLIGENCE.

In consideration of the permission granted or that may hereafter be granted to me by Blazer Ski Club, a Colorado nonprofit corporation, to participate in activities with the Blazer Ski Club, including alpine and nordic skiing, mountain climbing and mountaineering, traveling in mountainous terrain, backpacking, hiking, rafting, canoeing, cycling, ski instruction, parties, camping, picnics, club meetings, bus or airplane transportation hired by the club or car pools arranged among members and guests through the club and any other activities that the Blazer Ski Club may offer, I _____ (print name) And for the following minor member or minor guest of the club: _____ (print name) Acknowledge and agree as follows:

1) I understand that there are many inherent risks associated with the activities in which I may participate with the Blazer Ski Club, and I represent that I am fully capable of evaluating such risks. I agree that it is appropriate that I assume all of such risks for myself, as I hereby do, including the risk that the persons referred to as "Releasees" in the next paragraph may be negligent in their conduct or supervision of the activities; and I agree that Blazer Ski Club is entitled to rely upon my assumption of such risks, and upon the release provided herein, in allowing me to participate with Blazer Ski Club in such activities.

2) I hereby release and discharge Blazer Ski Club, it's officers, directors, members, leaders, instructors, and club volunteers being jointly and severally referred to as the "Releasees" from any and all claims and liabilities that arise out of any of the activities in which I may participate with the Blazer Ski Club, including, without limitations, those claims or liabilities that involve injury or death to me or damage to my property – even if such claims or liabilities may arise out of the negligence or other fault of any of the Releasees or of any person for whom any of the Releasees may be responsible.

3) This Agreement and Release shall remain in effect for so long as I continue to participate in activities of the Blazer Ski Club.

4) I agree that this Agreement and Release shall be binding upon me and my heirs and personal representatives and shall inure to the benefit of the Releasees and their respective heirs, personal representatives, and successors

5) As the parent or guardian of the above listed children, I agree to the above release of liability additionally to apply to them.
